# Detracting behavior ES Discipline Plan at KISJ

ES inappropriate behaviors fall into 3 levels of detractions.

Each level is addressed either by the classroom teacher or the school administration.

# Level 1 Detracting Behaviors

- Handled by the teacher with documentation of behavior and action taken (when applicable).
- The teacher will follow individual classroom hierarchies of behavior management.
- At least 3 interventions/strategies (one may be a parent contact) must be implemented before an office referral may be made.

#### Examples of Level 1 Detracting/Low Level Behaviors

These are examples of low level detracting misbehaviors.

Not following directions Running in hallways Excessive talking

Inappropriate laughing/sneering

Teasing/putdowns

Inappropriate language

Not using KISJ connecting language

Touching other students items

Eye rolling

Interrupting

Consistent tardiness

Name calling

Misuse of materials

Wandering

Mocking

Tech violation

Uniform violation

#### Level 1 Possible Teacher Responses

(teacher to student)

- Student completes the RUP Violation Sheets (Tech violation)
- Student completes <u>ES Dialogue Sheet</u>
- Verbal warning

- Student conference
- Time away (within the classroom)
- Move students desk/position in line

# Level 2 Detracting Behaviors

- Handled by the teacher with documentation of behavior and action taken
- Parent/guardian contact for 1st offense is highly suggested
- At least 3 interventions/strategies (one must be a parent contact) must be implemented before an office referral may be made

### Examples of Level 2 Detracting Behaviors

These are examples of recurring inappropriate level one behaviors or more serious level two behaviors that threaten the school community.

Back talking/arguing (recurring)
Inappropriate gestures/Language
Teasing/Taunting (recurring)
Refusing to work
Rumors/gossiping

Derogatory notes/pictures

Open defiance Lying Throwing objects

#### Level 2 Possible Teacher Responses

(teacher to student and parent)

- Detention in the classroom
- Contact the parent
- Student completes the <u>RUP Violation Sheet</u>(Tech violation)
- Student completes ES Dialogue Sheet

# Level 3 Detracting Behaviors

- Handled by the administration
- Teacher must complete the <u>Students Sent to the ES</u> Form and send the student to the ES Office with an ES Office Pass
- Administration will contact parents/guardians
- An appropriate consequence will be given and the classroom teacher will be informed.
- All Level 3 Detracting Behaviors will be recorded in Powerschool.
- Student Centered Interventions

#### Examples of Level 3 Detracting Behaviors

These examples represent violations of community expectations and are in direct contrast with our core beliefs and values of Respect and Responsibility. These behaviors are serious acts of misconduct and /or repeated misbehaviors.

(office to student and parent)

Hitting/Fighting

Ethnic slurs

Obscene gestures

Inappropriate touching

Damaging property

Direct and willful disobedience of school

rules and policies

Disruptive clothing

Disrespect for authority

Leaving school without permission

Physical/Verbal Assault

Bullying (Including Cyberbullying)

Threatening/taunting

Threatening bodily harm

Stealing

Use of profanity

Pulling fire alarm

Excessive truancy

Harassment, including sexual

Drugs

Weapons/facsimile of a

weapon/dangerous instrument

Cheating and plagiarism

# Before Office Discipline Referral for Level 1/2 Offense:

- 1. Parents and students must know teacher expectations and procedures.
- 2. Parents and students must know the classroom teacher's discipline plans and procedures.
- 3. Teachers must document unacceptable behaviors and consequences imposed, trying several strategies/interventions to stop the inappropriate behavior. A parent contact must be made before an office referral is made.

## Specialist Classes

The Specialist teachers (Art, IT, P.E., Librarian, Korean and Music) will follow the same level system of behaviors as the classroom teacher. The specialist teacher will report behavior problems to the classroom teacher by sending the classroom teacher an email or logging issues on the Specialist Class Report Sheet.

# Playground

The playground supervisors will also follow the level system of behaviors. Level 1 and 2 behaviors will be reported to the classroom teacher via email or logging issues on the Specialist Class Report Sheet. The teacher will then address the behaviors according to the classroom discipline plan. Level 3 behaviors will result in a direct office referral.
